Initiative Measure No. 1308 (to the people)

This measure would decrease licensing charges for certain liquor distributors, sellers, importers, and manufacturers. It would decrease the size of retail store space necessary to sell spirits, from 10,000 to 4,500 square feet. It would change licensing requirements for spirits importers and out-of-state manufacturers and distillers and allow out-of-state manufacturers to directly distribute some product in Washington. Women Working in Construction, United Trade Workers Association, et al v. Department of Labor Secretary Usery

Appeared as a plaintiff individually and a member of the United Trade Workers Association,¹ was a founding member and secretary of the organization. Case was a groundbreaking lawsuit that resulted in new federal regulations related to women working in the construction trades, and was written up in scholarly articles that recounted and analyzed the history of women's rights in the workplace:

"The activism of women in construction led to the first federal regulations against sexual harassment (41 C.F.R. §60-4, 1978). In the spring of 1975, female construction workers from all around the country met to discuss the hurdles they face entering this male-dominated field. A year later, they brought two lawsuits under Executive Orders 11246 and 11375, which prohibited federal contractors from discriminating on the basis of sex (Advocates for Women et al. v. Usery, Civil Action No. 76-0862, D.D. C., filed April 14, 1976; Women Working in Construction et al. v. Usery, Civil Action No. 76-527, D.D. C., filed April 13, 1976). The lawsuits protested sex discrimination in hiring practices and harassment of women in the construction industry and requested that the U.S. Department of Labor set hiring goals and timetables for women in the construction industry. The plaintiffs included Advocates for Women in San Francisco; Women in Trades in Seattle; United Trade Workers Association in Tacoma, Washington; and Women Working in Construction and Wider Opportunities for Women in Washington, D.C., all of which helped women obtain employment in the construction industry. In addition to the plaintiffs, women from several other organizations participated in the lawsuit..."

"As part of a settlement of these lawsuits, the Department of Labor adopted the first 15 federal regulations against workplace harassment based on sex in April of 1978. The regulations required federal construction contractors to ensure and maintain a working environment free of harassment, intimidation and coercion, and required contractors to assign two or more women to each construction project if possible."

¹ United Trade Workers Association – Founding member and Secretary of the UTWA organization that was active in Tacoma politics and labor law related to ensuring that minorities and women were allowed to become members of the local trade unions, particularly the operating engineers, cement finishers, carpentry, and labor unions. In addition the organization engaged in political and legal actions in order to ensure that contractors and sub-contractors for city, state, and federal public works projects hired minority and women trade workers to work on those projects. Gained extensive working knowledge about union labor contracts, presidential executive orders and federal civil rights and labor law during the course of my experience with the group.
